Eligibility criteria	<mark>10</mark>	Inclusion and exclusion criteria for participants. If applicable, eligibility criteria for study centres and individuals who will perform the interventions (eg, surgeons, psychotherapists)
Interventions	11a	Interventions for each group with sufficient detail to allow replication, including how and when they will be administered
	11b	Criteria for discontinuing or modifying allocated interventions for a given trial participant (eg, drug dose change in response to harms, participant request, or improving/worsening disease)
	<mark>11c</mark>	Strategies to improve adherence to intervention protocols, and any procedures for monitoring adherence (eg, drug tablet return, laboratory tests)

Recruitment	<mark>15</mark>	Strategies for achieving adequate participant enrolment to reach target sample size

Sequence generation	<mark>16a</mark>	Method of generating the allocation sequence (eg, computer- generated random numbers), and list of any factors for stratification. To reduce predictability of a random sequence, details of any planned restriction (eg, blocking) should be provided in a separate document that is unavailable to those who enrol participants or assign interventions
Allocation concealment mechanism	16b	Mechanism of implementing the allocation sequence (eg, central telephone; sequentially numbered, opaque, sealed envelopes), describing any steps to conceal the sequence until interventions are assigned
Implementation	<mark>16c</mark>	Who will generate the allocation sequence, who will enrol participants, and who will assign participants to interventions
Blinding (masking)	<mark>17a</mark>	Who will be blinded after assignment to interventions (eg, trial participants, care providers, outcome assessors, data analysts), and how
	<mark>17b</mark>	If blinded, circumstances under which unblinding is permissible, and procedure for revealing a participant's allocated intervention during the trial

Reference to where data collection forms can be found, if not in the protocol	
	18b	Plans to promote participant retention and complete follow-up, including list of any outcome data to be collected for participants who discontinue or deviate from intervention protocols	
Data management	19	Plans for data entry, coding, security, and storage, including any related processes to promote data quality (eg, double data entry; range checks for data values). Reference to where details of data management procedures can be found, if not in the protocol	
Statistical methods	20a	Statistical methods for analysing primary and secondary outcomes. Reference to where other details of the statistical analysis plan can be found, if not in the protocol	
	20b	Methods for any additional analyses (eg, subgroup and adjusted analyses)	
	20c	Definition of analysis population relating to protocol non-adherence (eg, as randomised analysis), and any statistical methods to handle missing data (eg, multiple imputation)

Harms	22	Plans for collecting, assessing, reporting, and managing solicited and spontaneously reported adverse events and other unintended effects of trial interventions or trial conduct
Auditing	<mark>23</mark>	Frequency and procedures for auditing trial conduct, if any, and whether the process will be independent from investigators and the sponsor

Research ethics approval	<mark>24</mark>	Plans for seeking research ethics committee/institutional review board (REC/IRB) approval
Protocol amendments	<mark>25</mark>	Plans for communicating important protocol modifications (eg, changes to eligibility criteria, outcomes, analyses) to relevant parties (eg, investigators, REC/IRBs, trial participants, trial registries, journals, regulators)
Consent or assent	<mark>26a</mark>	Who will obtain informed consent or assent from potential trial participants or authorised surrogates, and how (see Item 32)
	<mark>26b</mark>	Additional consent provisions for collection and use of participant data and biological specimens in ancillary studies, if applicable
Confidentiality	<mark>27</mark>	How personal information about potential and enrolled participants will be collected, shared, and maintained in order to protect confidentiality before, during, and after the trial
Declaration of interests	<mark>28</mark>	Financial and other competing interests for principal investigators for the overall trial and each study site
Access to data	<mark>29</mark>	Statement of who will have access to the final trial dataset, and disclosure of contractual agreements that limit such access for investigators
Ancillary and post-trial care	<mark>30</mark>	Provisions, if any, for ancillary and post-trial care, and for compensation to those who suffer harm from trial participation

Dissemination policy	31a	Plans for investigators and sponsor to communicate trial results to participants, healthcare professionals, the public, and other relevant groups (eg, via publication, reporting in results databases, or other data sharing arrangements), including any publication restrictions
	<mark>31b</mark>	Authorship eligibility guidelines and any intended use of professional writers
	<mark>31c</mark>	Plans, if any, for granting public access to the full protocol, participant-level dataset, and statistical code

Informed consent materials	<mark>32</mark>	Model consent form and other related documentation given to participants and authorised surrogates
Biological specimens	<mark>33</mark>	Plans for collection, laboratory evaluation, and storage of biological specimens for genetic or molecular analysis in the current trial and for future use in ancillary studies, if applicable
